What's going on in the SACC for March 2022....

From the Executive Directors Desk...

Hello Valued Members,

It's that time of year when there is another grant opportunity available, the <u>Afflicted Business Relief</u> program. This grant is through the State of Michigan and has 400 million-plus to give out. As usual, it's fairly complicated. There is a list of eligible businesses and the refunds they are offering.

Business types are at the link below and the possible refunds include; property taxes, State unemployment insurance, lease refunds, and certain licensees you may have paid for. These are all for expenses paid in 2020 and have varying refund amounts/ percentages. The first qualification is Your business has to have a decline in total Michigan sales between the calendar year 2019 and 2020 equal to or greater than 5 percent. However, if you had PPP or Restaurant Revitalization and other money forgiven or given, you need to include all of those dollars in the application regardless of the year it was received. Then they do a calculation to determine the amount added back to your sales for that year then do another calculation to determine the amount you'll receive. See not confusing at all. I encourage everyone to check out the website here for details. https://www.michigan.gov/abr.

Another interesting aspect of this is that it looks like it is not a first come first serve basis, that they will prorate the monies so everyone gets something. With that being said, you may not get the full calculated max dollars depending on how many businesses apply. The window to apply is March 1 st through March 31 st with a payout by July 1st. Documents needed: see here in the FAQ; https://www.michigan.gov/abr/faqs It is my understanding that these will have some updates with calculation details and checklist in the coming days.

Something to consider with this one is they are prorating the amounts you'll receive so it will be impossible to know how much you'll end up with when you apply.
